Affiliates	 Companies related by common ownership or control such as: Envoy Mortgage (India) Private Limited Place, Inc. and related "Powered by Place" real estate teams Construct Title Company, LLC and related Blueprint Title Agencies

Nonaffiliates	Companies not related by common ownership or control. They can be financial or nonfinancial companies. Nonaffiliates we share with can include companies providing business process services or engaged in direct marketing and the selling of consumer products and services.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Envoy Mortgage, Ltd. does not jointly market.
